

INSTRUCTIONS AND SELF-DECLARATION FORM

Keeping in view of the health and safety of all, the Walk-in-Interview will be conducted by following COVID-19 guidelines such as social distance norms, wearing Face Mask, sanitization etc. All Candidates are required to follow these norms.
